THE VICTIM STATES TO R/O THAT AFTER A CAR AND BIKE SHOW THAT TOOK PLACE AT THE FOOTBALL STADIUM , HE OBSERVED THE PERSON IN QUESTION BY THE NAME OF CHAD WASHINGTON SECURE A GRILL THAT WAS LOANED TO HIM BY THE VICTIM(S). VICTIM STATES THAT HE OBSERVED THE PERSON IN QUESTION MR. WASHINGTON SECURE THE GRILL AT THE FOOTBALL STADIUM INSIDE A LOCKED GATE AND THE PERSON QUESTION REASSURED HIM THAT IT WAS SECURE AND THAT THERE WAS NO WAY POSSIBLE THAT IT WOULD BE TAKEN FROM THE SECURE LOCATION. THE VICTIM STATES THAT THERE WERE SEVERAL ATTEMPTS MADE TO RETRIEVE THE GRILL DELUX BLACK IN COLOR 4X8 IN WIDTH WITH TWO EXTERNAL BURNERS AND TWO PROPANE TANKS VALUED AT 3200 DOLLARS. WASHINGTON PROCRASTINATED TO MEET WITH THE VICTIM AND GAVE HIM THE RUN AROUND SEVERAL TIMES. THE VICTIM STATES TO R/O THAT HE TEXTED AND CALLED MR.WASHINGTON WHO KEPT PROCRASTINATING. WHEN THE VICTIM DID MAKE CONTACT WITH MR.WASHINGTON HE STATED THAT HE WAS UNAWARE OF THE WHERE ABOUTS OF THE GRILL. R/O DID SPEAK WITH THE VICTIM(S) AND THE FATHER OF THE PERSON IN QUESTION ABOUT THE WHERE ABOUTS OF THE GRILL WHICH NO ONE CAN GIVE A LOCATION ON THE GRILL. THIS REPORT WILL BE FORWARDED TO CAPT. PAULING FOR A FURTHER INVESTIGATION. ON AUG. 29,2013 R/O SPOKE WITH THE VICTIM LT. CRAWFORD WHO WAS ABLE TO GIVE AN IDENTIFIER THAT WOULD HELP INVESTIGATIONS. VICTIM STATED THAT THE GRILL HAS A BRASS PLACARD 3"X 3" ON THE UPPER LEFT REAR THAT READS, " BUILT BY JAMIL SHRINERS 2010." VICTIM STATES THAT THIS GRILL IS THE ONLY ONE THAT HAS THAT TYPE OF IDENTIFIER.

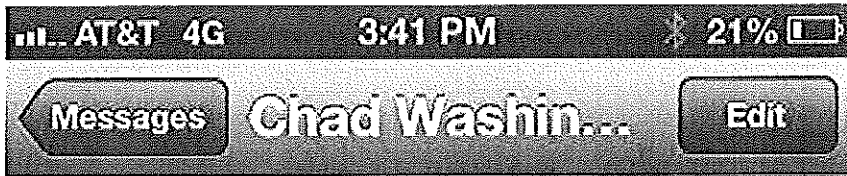
