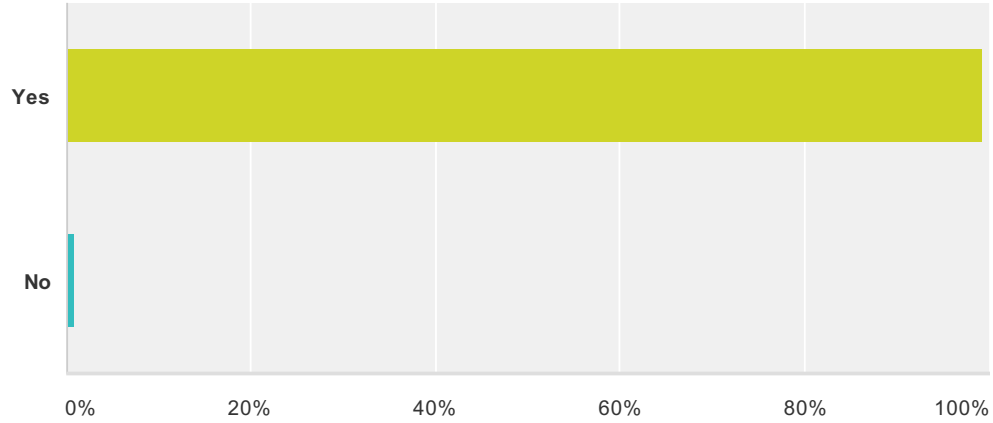

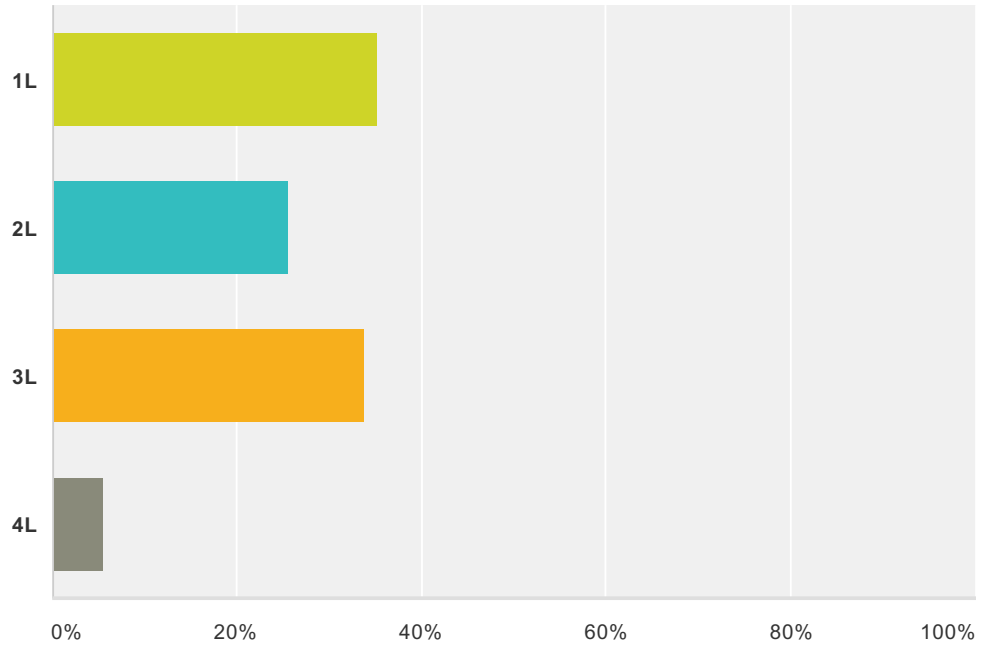

Q2 Are you currently a 1L, 2L, 3L, or 4L?

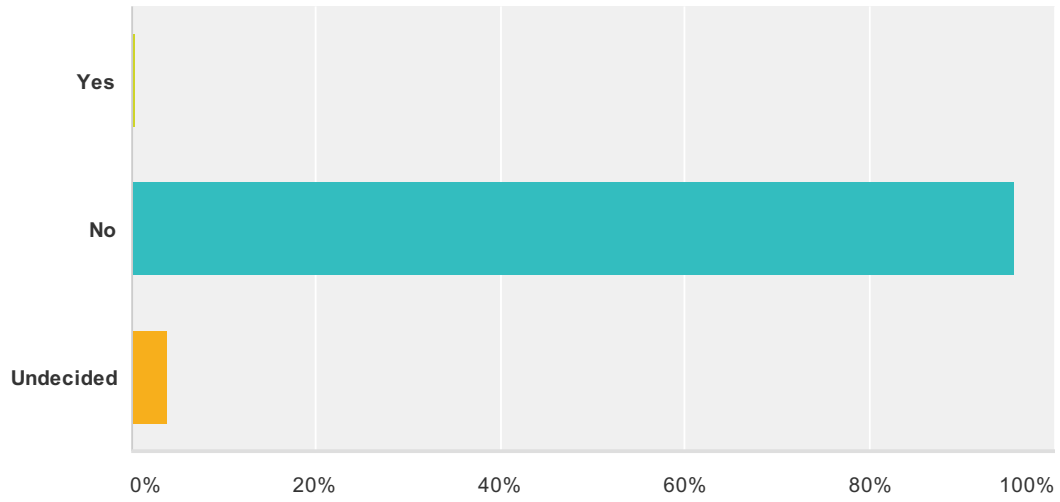

Q3 Do you support the sale of the Charleston School of Law to InfiLaw?

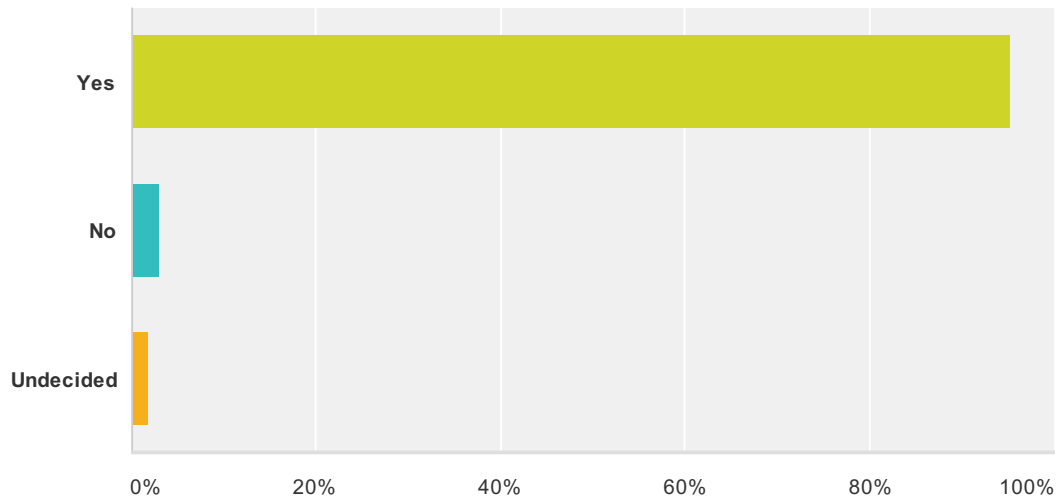

Q4 Do you believe that students should have a voice in discussions regarding ownership of the law school?

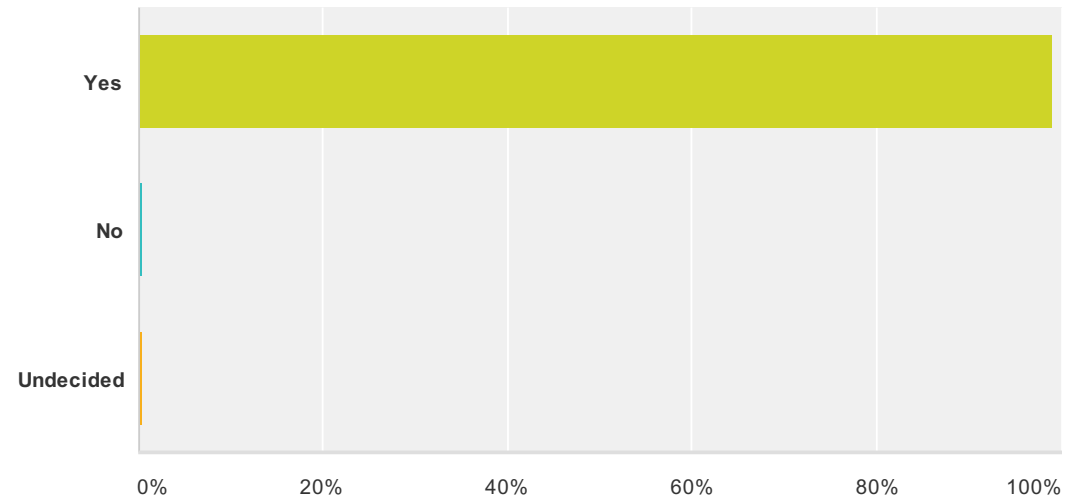

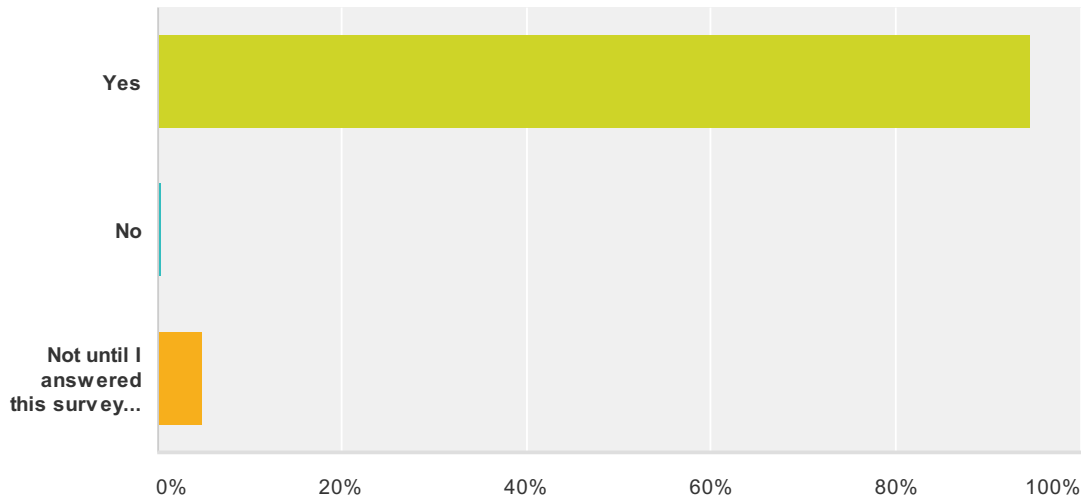

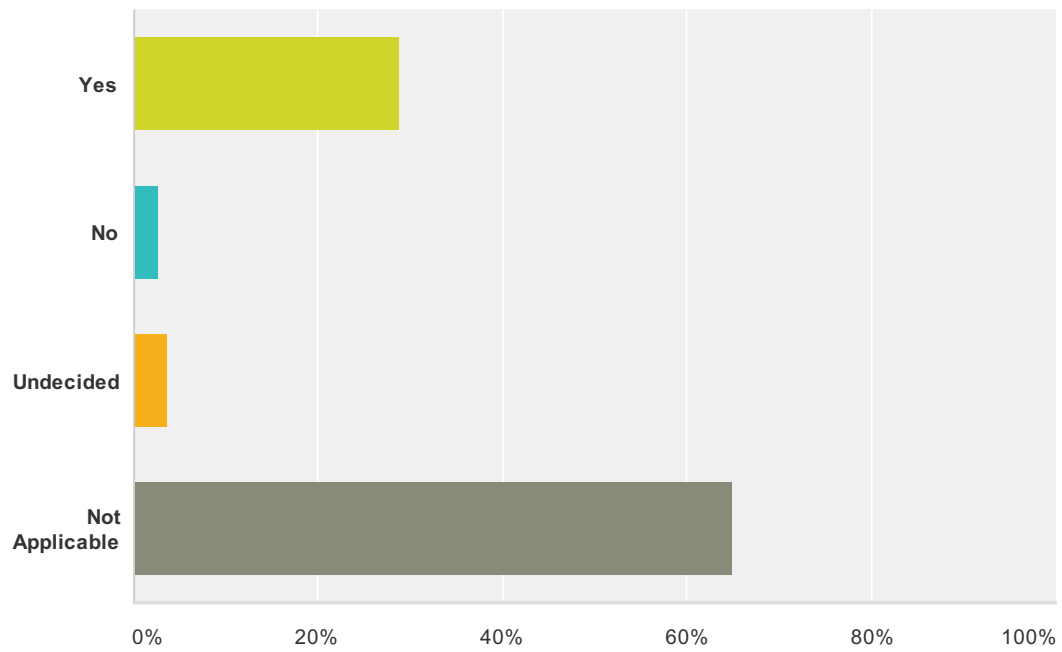

Q7 If you are a 1L, are you considering transferring if the proposed sale to InfiLaw goes through?

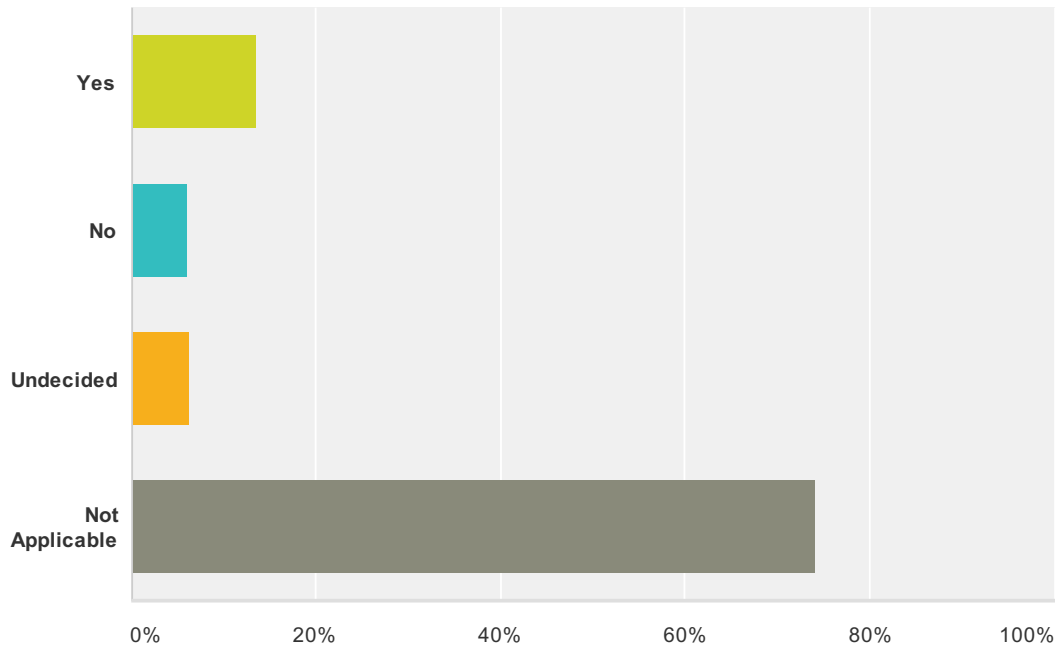

Q8 If you are a 2L, are you considering transferring if the proposed sale to InfiLaw goes through?

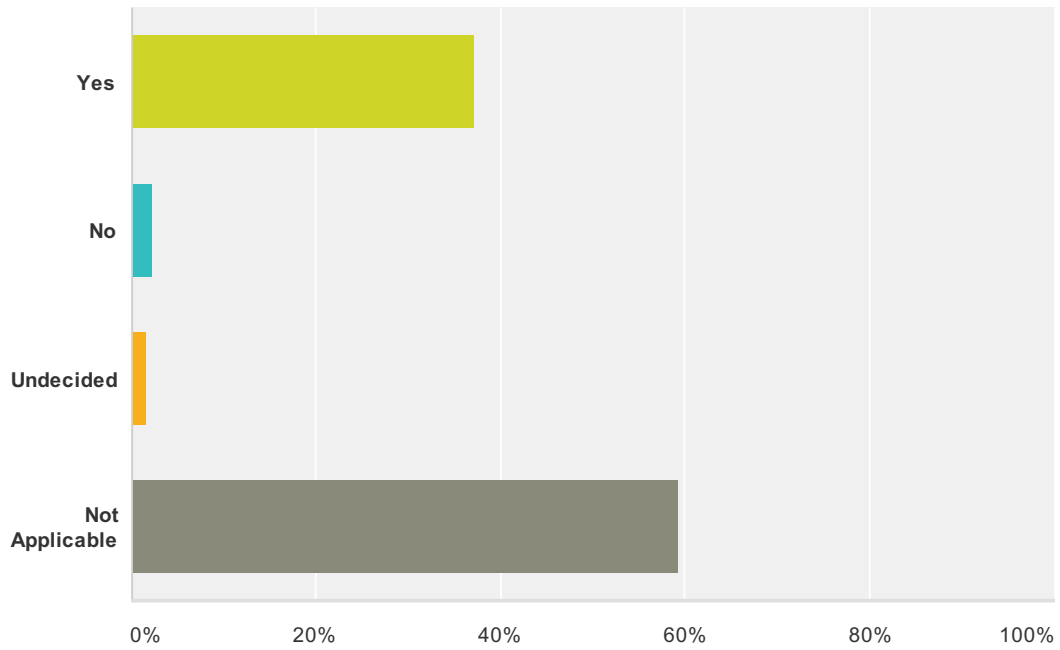
