NARRATIVE	VEHICLES AND TWO OFFICERS STANDING BESIDE A WHITE MALE IN A CAMOUFLAGE COAT AND BLUE JEANS. I MET WITH CPL. SCHEETZ FROM HANAHAN POLICE DEPARTMENT; I ALSO MET WITH OFC. JUSTICE JENKINS FROM HANAHAN POLICE DEPARTMENT. OFFICER JENKINS ADVISED ME THAT HE WAS ON HIS WAY TO WORK WHEN THE SILVER FORD PICKUP APPROACHED HIM FROM HIS REAR AT A HIGH RATE OF SPEED. HE STATED THAT THE TRUCK SWERVED AROUND HIS MARKED PATROL CAR AND NEARLY LOST CONTROL. HE FURTHER STATED THAT THE PICKUP SPED AWAY AT SPEEDS IN EXCESS OF 100 MPH, AGAIN SWERVING ALL OVER THE ROAD AND NEARLY LOSING CONTROL AT LEAST TWO ADDITIONAL TIMES. OFFICER JUSTICE STATED THAT HE OBSERVED THE TRUCK SPEED THROUGH A RED LIGHT AT TANNER ROAD; HE ALSO STATED THAT THE DRIVER NEVER ACKNOWLEDGED HIS BLUE LIGHTS AND SIREN. OFC JENKINS ADVISED THAT THE PICKUP SLOWED DOWN WHEN IT ENTERED THE 35 MPH ZONE AND MADE A RIGHT TURN ONTO BANKTON CIRCLE. CPL. SCHEETZ ADVISED ME THAT WHEN OFFICERS APPROACHED THE VEHICLE AFTER IT WAS STOPPED, THEY ASKED MR DEWITT TO STEP OUT OF THE VEHICLE. WHEN MR DEWITT STARTED TO GET OUT OF THE TRUCK HE DID NOT PLACE IT IN PARK AND THE TRUCK STARTED TO ROLL FORWARD. 2 OFFICERS HAD TO JUMP ONTO THE SIDE OF THE TRUCK TO PLACE IT IN PARK WHILE IT CONTINUED TO ROLL. CPL. SCHEETZ ADVISED THAT THE OFFICERS COULD SMELL THE ODOR OF ALCOHOLIC BEVERAGE COMING FROM HIM AND THAT THERE WAS AN OPEN CONTAINER INSIDE THE TRUCK.										
	I APPROACHED THE WHITE MALE IDENTIFIED AS HENRY WAYNE DEWITT. I COULD SMELL AN ODOR OF ALCOHOLIC BEVERAGE COMING FROM HIS PERSON. I NOTICED THAT HIS EYES WERE DROOPY, BLOODSHOT AND GLASSY. I IDENTIFIED MYSELF AND ADVISED WHY I WAS ON SCENE. WHEN QUESTIONED ABOUT THE COLLISION, HE ADVISED ME THAT THE CAR STOPPED RIGHT IN FRONT OF HIM. HE SAID HE THOUGHT THE TAILGATE WAS ALREADY UP AND BASICALLY STOPPED IN THE ROAD. WHEN I ASKED HIM ABOUT A TAILGATE BEING UP, MR. DEWITT WAS UNCERTAIN. HE SAID HE DID NOT KNOW FOR SURE WHAT KIND OF VEHICLE HE HAD STRUCK, BUT THAT IT MAY HAVE BEEN A SMALL CAR. I ADVISED MR. DEWITT THAT I WAS TOLD BY OTHER OFFICERS THAT HE HAD BEEN DRINKING AND ASKED HIM IF THIS INFORMATION WAS CORRECT. HE ANSWERED "YES". HE SAID HE HAD LAST DRANK AROUND 4 AND THOUGHT HE HAD ONE DRINK. I ASKED HIM IF HE WOULD PERFORM FIELD SOBRIETY AND HE STATED "SURE".										
	MR. DEWITT WAS THEN ADVISED TO REMOVE HIS HAT FOR THE HGN PORTION OF THE FIELD SOBRIETY

NARRATIVE	TEST. HE DID TELL ME THAT HE WAS WEARING SOFT CONTACTS. DURING THE HGN TEST, MR. DEWITT HAD TO BE REMINDED AT LEAST TWICE TO HOLD HIS HEAD STILL. I OBSERVED A LACK OF SMOOTH PURSUIT IN BOTH EYES AS HE FOLLOWED MY PEN (STIMULUS). IN CONTINUING THE TEST, I OBSERVED DISTINCT AND SUSTAINED NYSTAGMUS AT MAXIMUM DEVIATION IN BOTH EYES AS WELL AS THE ONSET PRIOR TO 45 DEGREES IN BOTH EYES.				
	THE NEXT TEST WAS THE WALK AND TURN. WHEN I INSTRUCTED HIM TO STAND WITH HIS RIGHT FOOT IN FRONT OF HIS LEFT, HE LOST HIS BALANCE WHEN HE ATTEMPTED TO DO SO. HE TOOK A COUPLE OF SMALL STEPS SIDEWAYS TO REGAIN HIS BALANCE. WHEN HE TRIED AGAIN, HIS FEET DID NOT TOUCH HEEL TO TOE AND HE LOST HIS BALANCE AGAIN. MR. DEWITT ATTEMPTED TO STAND AS INSTRUCTED AND LOST HIS BALANCE AT LEAST TWO MORE TIMES BEFORE I WAS ABLE TO CONTINUE WITH GIVING THE VERBAL INSTRUCTIONS. AFTER LOSING HIS BALANCE AGAIN, HE DECIDED HE WANTED TO TAKE HIS BOOTS OFF AND REACHED OUT TO ME. HE GRABBED MY LEFT ARM FOR BALANCE AND REMOVED HIS BOOTS.				
ADMINISTRATIVE	EVEN WITHOUT HIS BOOTS ON, MR. DEWITT CONTINUED TO LOSE HIS BALANCE DURING THE INSTRUCTIONAL PHASE. WHEN I BEGAN TO WALK AND DEMONSTRATE, HE ATTEMPTED TO WALK WITH ME. I INSTRUCTED HIM AGAIN NOT TO MOVE UNTIL I TOLD HIM TO DO SO. HE RETURNED AND I TRIED AGAIN TO COMPLETE THE INSTRUCTIONS.
