REPORTING OFFICER WAS NOTIFIED BY OFFICER BORTHEN OF A POSSIBLE IMPAIRED DRIVER IN THE 900 BLOCK OF ASSEMBLY STREET. REPORTING OFFICER ARRIVED ON SCENE AND MET OFFICER BORTHEN WHO STATED THAT WHILE AT THE LIGHT AT ASSEMBLY STREET AND GERVAIS STREET, HE OBSERVED A VEHICLE TRAVELING SOUTHBOUND ON ASSEMBLY STREET IN THE NORTHBOUND LANE. OFFICER BORTHEN CONDUCTED A TRAFFIC STOP AND IDENTIFIED THE DRIVER BY HIS SOUTH CAROLINA DRIVER'S LICENSE (PLOWDEN, MARK WELLINGTON).

REPORTING OFFICER MADE CONTACT WITH PLOWDEN AND REQUESTED HIM TO EXIT THE VEHICLE TO CONDUCT FIELD SOBRIETY TESTS (SFST'S) TO SEE IF HE WAS OKAY TO DRIVE. PLOWDEN COMPLIED AND EXITED THE VEHICLE NEEDING TO USE THE DOOR AND THE SIDE OF THE VEHICLE FOR BALANCE. REPORTING OFFICER DETECTED A MODERATE ODOR OF AN ALCOHOLIC BEVERAGE EMITTING FROM PLOWDENS BREATH AND PERSON. PLOWDEN THEN ASK IF HE WAS GOING TO BE GIVEN TEST(S) BEFORE STATING THAT HE WAS NOT GOING SUBMIT TO THEM.

REPORTING OFFICER MOVED PLOWDEN IN FRONT OF THE REPORTING OFFICERS PATROL VEHICLE AND PLACED PLOWDEN UNDER ARREST. PLOWDEN WAS HANDCUFFED (HANDS SECURED IN THE REAR AND DOUBLE LOCKED FOR SAFETY). PLOWDEN WAS READ HIS MIRANDA RIGHTS ON CAMERA IN FRONT OF THE PATROL VEHICLE. PLOWDEN WAS SEARCHED INCIDENT TO ARREST AT WHICH POINT PLOWDEN STATED THAT HE HAD A LOADED PISTOL IN THE VEHICLE. PLOWDEN WAS PLACED INTO THE REPORTING OFFICERS VEHICLE. REPORTING OFFICER AND OFFICER BORTHEN INVENTORIED THE VEHICLE AND LOCATED A LOADED RUGER LCP9 IN THE CENTER CONSOLE IN A HOLSTER. REPORTING OFFICER CALLED FOR A DISTRICT ROTATIONAL TOW FOR PLOWDEN'S VEHICLE, AND HOWARDS GARAGE WAS NOTIFIED AND RESPONDED.

PLOWDEN WAS TRANSPORTED TO THE ALVIN S GLENN DETENTION CENTER BA ROOM. UPON ARRIVING, THE REPORTING OFFICER ACTIVATED THE SLED RECORDING SYSTEM. PLOWDEN WAS AGAIN READ HIS MIRANDA RIGHTS ON CAMERA, AND READ HIS SOUTH CAROLINA IMPLIED CONSENT RIGHTS WHICH PLOWDEN SIGNED, STATING HE UNDERSTOOD. PLOWDEN'S MOUTH WAS CHECKED FOR ANY FOREIGN OBJECTS, WHICH WAS CLEAR. AFTER THE 20 MINUTE OBSERVATION PERIOD, PLOWDEN REFUSED TO SUBMIT TO A BREATH SAMPLE. AFTER THE DMT PROCESS WAS FINISHED, PLOWDEN WAS ISSUED A SOUTH CAROLINA NOTICE OF SUSPENSION, WHICH HE SIGNED STATING HE UNDERSTOOD HE COULD NOT DRIVE. AFTERWARD, PLOWDEN WAS TURNED OVER TO ALVIN S GLENN DETENTION CENTER STAFF.

AT NO TIME DURING THE TRAFFIC STOP UP TILL PLOWDEN WAS ARREST DID HE IDENTIFY HIMSELF AS A CONCEALED WEAPONS PERMIT HOLDER NOR DID HE STATE THAT HE HAD A LOADED FIREARM IN THE VEHICLE. OFFICER BORTHEN SAFELY SECURED THE PISTOL IN THE PROPERTY ROOM FOR SAFE KEEPING.
