ST. MATTHEWS WOMAN CHARGED WITH BREACH OF TRUST WITH FRAUDULENT INTENT

Agents of the S.C. Law Enforcement Division Friday arrested a St. Matthews woman in connection with transferring funds from a school band booster club to her personal account.

Charlene Lewis Fludd, 41, of St. Matthews, S.C., was charged with **Breach of Trust** with Fraudulent Intent, value more than \$2,000 but less than \$10,000, a felony which carries a penalty upon conviction of up to five years in prison or a fine at the discretion of the court.

Fludd was booked at the Calhoun County Sheriff's Department.

The case was investigated by SLED at the request of the Calhoun County Sheriff's Department.

The case will be prosecuted by the First Circuit Solicitor's Office.
