ON THIS DATE, I ARRIVED AT THE INCIDENT LOCATION (2391 ROPER MTN. RD.) AND MET WITH THE VICTIM (R JOSEPH VARIEUR 2391 ROPER MTN. RD. SIMPSONVILLE, SC 29681 WM 09/17/69 40 915-9871) IN REFERENCE TO A DISTURBANCE WHICH ORIGINALLY OCCURRED ON 08/21/10 AT 0300 HOURS AT THE INCIDENT LOCATION.

THE VICTIM STATED THAT HE WAS ASLEEP IN HIS BEDROOM ON 08/21/10 WHEN HE WAS ABRUPTLY AWAKEN UP BY LOUD SCREAMING COMING FROM A MALES VOICE IN HIS BACK YARD. THE VICTIM STATED THAT HE GOT OUT OF BED AND LOOKED OUT THE BACK DOOR AND NOTICED HIS 15 YEAR OLD DAUGHTER AND SOME OF HER FRIENDS SITTING IN CHAIRS AT AN OUTSIDE BAR IN THE BACK YARD WITH THE SUSPECT, WHOM THE VICTIM IDENTIFIED AS HIS NEIGHBOR WHOM HE HAS RECENTLY HAD VARIOUS DISTURBANCES WITH, STANDING VERY CLOSE TO HIS DAUGHTER AND HER FRIENDS WHILE YELLING AT THEM FOR AN UNKNOWN REASON. THE VICTIM STATED THAT HE GOT DRESSED AND WALKED OUTSIDE AND CONFRONTED THE SUSPECT AND ASKED THE SUSPECT WHY HE WAS IN HIS BACK YARD YELLING AT HIS DAUGHTER AND HER FRIENDS. THE VICTIM STATED THAT HIS DAUGHTER AND HER FRIENDS THEN WENT SAFELY INTO THEIR HOUSE AND THE SUSPECT APPROACHED THE VICTIM AND GRABBED THE VICTIM BY THE FRONT UPPER PORTION OF HIS SHIRT NEAR HIS NECK AND THEN SHOVED THE VICTIM WITH THE SUSPECTS HANDS INTO A LARGE POTTED PLANT IN THE BACK YARD WHICH THE VICTIM FELL OVER AND ONTO THE GROUND. THE VICTIM STATED THAT HE GOT UP OFF THE GROUND AND THE SUSPECT THEN WENT TO THE REAR PORTION OF THE VICTIMS PROPERTY AND STARTED OPENING AND CLOSING THE METAL GATE AND THEN LEFT THE PROPERTY AND WENT BACK TO HIS HOUSE.

I INITIALLY RESPONDED TO THE INCIDENT LOCATION ON THE ORIGINAL INCIDENT DATE AND MET WITH THE VICTIM AND THERE WERE NO PHYSICAL MANIFESTATION OF AN ASSAULT TO THE VICTIM AT THAT TIME. I THEN MET WITH THE SUSPECT AND QUESTIONED HIM ABOUT THIS INCIDENT. THE SUSPECT

STATED THAT THERE WAS A LOUD PARTY AT THE INCIDENT LOCATION AND THAT THE VICTIMS DAUGHTER REMOVED HIS MAILBOX FROM THE GROUND AND THREW THE MAILBOX AT HIS FRONT DOOR. I LOOKED AT THE SUSPECTS MAILBOX WHICH HAD NOT BEEN REMOVED AND WAS IN TACT AND IN ITS PROPER PLACE BY THE ROADSIDE. THE SUSPECT THEN WENT INSIDE HIS RESIDENCE WHERE HE REMAINED FOR THE REST OF THE NIGHT. I THEN MET BACK WITH THE VICTIM AND GAVE THE VICTIM INSTRUCTIONS ON HOW TO OBTAIN A TRESPASS NOTICE FOR THE SUSPECT FOR THE VICTIMS PROPERTY AND TO NOTIFY THE SHERIFFS OFFICE IF THE SUSPECT RETURNS TO THEIR PROPERTY. 

RIGHTS OF CRIME VICTIMS

*To be treated with fairness, respect and dignity throughout the criminal and juvenile justice process. Victims have a right to be informed of their constitutional rights. * To be reasonably informed when the accused or convicted person is arrested, released, or has escaped. *To be informed of all criminal proceedings, and to be present at those proceedings, when the accused also has the right to be present, for the disposal of charges. *To submit a written or oral statement at all hearings affecting bond or bail of the accused. * To be heard at any proceeding involving a post-arrest decision, a plea, or sentencing. * To be reasonably protected from the accused or persons acting on his/her behalf throughout the criminal justice process. *The right to confer with the prosecution after the accused has been charged, or before the trial, or before the disposition of the charges. The victim must be informed of the disposition. * After the conclusion of the criminal investigation, the victim has the right to reasonable access to all documents relating to the crime committed against them before trial. *To receive prompt and full restitution from the convicted person or persons. *To be informed of any proceeding for any post-conviction action or hearing and to be present at any hearing. *To a reasonable disposition and a prompt and final conclusion of their case.
