On Wednesday July 17, 2019, additional videos and text messages from ##### state that he is on his way to shoot up the school which constitutes the crime of Student Threats, SC statue 16-17-425. This text also had an accompanying video of ##### shooting a long gun. This particular post is dated May 11, 2019, at 12:34 pm.

In these videos of ##### shooting a gun he is using what appears to be an automatic rifle and a shotgun.
