Personally appeared before me, a magistrate of this county, one S/A Steven Bechtold, SLED who first being duly sworn, deposes and says that, **ROBERT ANDERSON STRICKLAND, JR (White Male, DOB [REDACTED])**, did within this county and state on or about: November 7, 2019 violate the criminal laws of the State of South Carolina in the following particulars:

DESCRIPTION OF OFFENSE

DOMESTIC VIOLENCE, 2ND DEGREE 16-25-20

The affiant states there is probable cause to believe that the defendant named above did commit the crime(s) set forth, and that such probable cause is based upon the following facts:


That on November 7, 2019, defendant did willingly, knowingly, and unlawfully violate S.C. statute Domestic Violence, 2nd Degree, 16-25-20 while at [REDACTED] in the County of Colleton, SC in the following particulars:

On November 7, 2019 at approximately 10:00 pm, **STRICKLAND** did, during an argument, assault his [REDACTED] by punching her in the face, with a closed fist, more than once, which caused moderate bodily injury. [REDACTED] also sustained a defensive injury to her arm in an attempt to protect her face. Further, **STRICKLAND**, physically took possession of both of [REDACTED] cell phones, blocking her access to both cell phones, preventing her from reporting the incident or receiving emergency medical assistance. **STRICKLAND** also damaged the vehicle [REDACTED] was attempting to flee in. [REDACTED] corroborated the above information. The injuries were also photographed by SLED agents and they are consistent with her recollection of events.

The above facts are true and believable based on the experience, knowledge, and investigation conducted by South Carolina Law Enforcement Division Special Agents.
