PLEASE TAKE NOTICE that on the tenth day hereafter or on a date prior to May 31,2021 (expedited request), the undersigned, on behalf of the State of South Carolina, will move and does hereby move this Court for an Order reinstating Uniform Traffic Tickets #20212350451590 Driving Under the Influence and #20212350451591 Driving Under Suspension that were dismissed by the Fairview Austin Summary Court on April 20, 2021 at 1:20pm for the following grounds:

- On March 4, 2021 at approximately 12:56 a.m., Defendant Heidi Hinsdale was arrested by Trooper D. Gonzalez and charged with *Driving Under the Influence* (Ticket # 20212350451590) and *Driving Under Suspension* (Ticket # 20212350451591) in Greenville County. A bench trial (non-jury) was scheduled for April 20, 2021 on both charges. See Exhibit A.
- 2. On March 25, 2021, the Defendant, by and through her attorney Lucas C. Marchant, filed a written Request For Jury Trial for both offenses identified above with the Fairview Austin Summary Court in Simpsonville, South Carolina. See Exhibit B.

- 3. In accordance with a long-standing practice originally implemented pursuant to a 2007

 Supreme Court Administrative Order and continued as a normal course of business in the

 Greenville County Summary Courts, all magistrate-level criminal cases wherein a

 Defendant requests a jury trial are removed from the bench trial docket and transmitted to
 the Office of the Solicitor, Thirteenth Judicial Circuit (hereinafter The Solicitor's Office)
 for future jury trial docketing and disposition.
- 4. On the charges referenced herein, at some point after the Request For Jury Trial was made on March 25, 2021 but prior to (or concurrent with) the Defendant's originally scheduled bench trial on April 20, 2021, the Defendant's attorney prevailed upon the Summary Court Jury Trial Coordinator to **not** transmit the Defendant's jury trial request to The Solicitor's Office. See Exhibit C.
- 5. Although Defendant's case file and Request for Jury Trial were not transmitted to The Solicitor's Office, Defendant's attorney did, however, forward discovery motions directly to The Solicitor's Office and his notice that he represented the Defendant on these charges. See Exhibit D.
- 6. Upon receiving the notice of representation and discovery motions from Defendant's attorney, The Solicitor's Office staff awaited transmittal of the tickets and case file from the Summary Court. After several weeks had passed without receiving the transmittal from the Court, The Solicitor's Office staff checked the Greenville County Central Index to determine the status of the charges. Upon checking the Central Index records, it was determined that both tickets had been disposed on April 20, 2021 and marked as "Not Guilty Bench Trial." See Exhibit E.

- 7. It is well established that neither the Defendant nor the State's witnesses need to appear for the originally scheduled bench trial once a Request For Jury Trial has been made, as the case is thereafter being prosecuted by the Solicitor's Office and not the arresting officer. In fact, Trooper Gonzalez did not appear in the Fairview Austin Summary Court on April 20, 2021, and his absence would not have permitted the Court to conduct a "bench trial" as referenced on the Central Index due to the lack of a testifying State witness.
- 8. Moreover, the State should have been notified of the Defendant's attorney's intent to effectively withdraw the request for a jury trial on or before the April 20, 2021 bench trial date and given the opportunity to object in accordance with Rule 14(b) of the South Carolina Rules of Criminal Procedure.
- 9. Pursuant to Rule 14(b) of the South Carolina Rules of Criminal Procedure, the Defendant may thereafter waive her right to a jury trial <u>only</u> with the approval of the Solicitor and the trial judge and the State was not given the opportunity to object to the Defendant's request to withdraw her jury trial request. <u>See Exhibit F. See also State v. Shuck, 278 S.C. 441; 298 S.E.2d 95 (1982); Op. S.C. Att'y Gen., 9286/9836 (February 2, 2015) (referencing the applicability of Rule 14(b), SCRCrimP to a summary court-level offense).</u>
- 10. The State was prejudiced by the denial of its opportunity to object to Defendant's request to have the case called on the original bench court date, resulting in dismissal of the charges. Further, a review of Defendant's record reveals that she was convicted of first offense DUI on April 14, 2020, and her March 4, 2021 DUI charge would be classified as second offense DUI with jurisdiction in the Court of General Sessions. See Exhibit G.

- 11. Following the "Not Guilty Bench Trial" ruling on April 20, 2021, and upon motion of the Defendant's attorney, Orders were issued for the "Destruction of Arrest Records" relating to these charges. The expungement would statutorily take effect "no sooner than the appeal expiration date and no later than thirty days after the appeal expiration date". S.C. Code Ann. 17-22-950(c). See Exhibit H.
- 12. A review of other Orders issued for the "Destruction of Arrest Records" on April 20, 2021 involving DUI charges made by Trooper D. Gonzalez reveals that five other DUI cases were ended by way of dismissal, *nolle prossed*, or the defendant was found not guilty. To the extent any of these cases contain a jury trial request made by a defendant on or before April 20, 2021, and should the Court grant the relief requested herein, the State respectfully requests that those tickets be restored and transmitted in a similar fashion as outlined below. Ref: Ticket #s 202023502-11115, -58137, -71435, 202123504-44697, -63110.

Based on the foregoing, the State respectfully requests the Summary Court recall and reinstate Ticket #s 20212350451590 (DUI) and 20212350451591 (DUS); (2) transmit Ticket # 20212350451591 (DUS) and the associated case file to The Solicitor's Office Magistrate Prosecution Unit; and (3) transmit Ticket # 20212350451590 (DUI) to the Greenville County Clerk of Court pursuant to Rule 3(a) of the South Carolina Rules of Criminal Procedure for the following reasons:

A. Defendant's record reflects an April 14, 2020 conviction for Driving with a Unlawful Alcohol Concentration (DUAC); and

B. Based on Defendant's prior DUAC conviction within the past ten (10) years, Ticket #20212350451590 would be considered a Second Offense for sentencing purposes and triable within the exclusive jurisdiction of the Court of General Sessions.






