ON 04-03-2006 AT APPROXIMATELY 1923 HOURS MYSELF AND OFC. STEINBRUNNER WERE DISPATCHED TO 4177 CLUB COURSE DR IN REFERENCE TO A DOMESTIC DISPUTE. UPON ARRIVAL WE SPOKE WITH THE COMPLAINANT, HOMRICH, KATHERINE WHO STATED THAT HER AND HER HUSBAND HAD BEEN ARGUING OVER THE CHILDREN. SHE STATED THAT THEY ARE LEGALLY DIVORCED HOWEVER THE VISITATION IS SET UP BETWEEN THE TWO OF THEM VERBALLY. THE COMPLAINANT STATED THAT THEY HAVE NOT HAD ANY PROBLEMS FOR A WHILE AND NOW THE COMPLAINANT IS UPSET THAT HER HUSBAND, THE SUBJECT, HOMRICH, DOUG IS SEEING A FEMALE THAT THEY HAVE AGREED TO KEEP THE CHILDREN AWAY FROM. THE COMPLAINANT ADVISED THAT SHE WENT OVER TO THE SUBJECTS RESIDENCE TO SPEAK TO HIM IN REFERENCE TO [REDACTED] THE SUBJECTS GIRLFRIEND WHEN AN ARGUMENT ENSUED.

THE COMPLAINANT STATED THAT THE SUBJECT WENT TO COME INTO HER VEHICLE THROUGH THE WINDOW WHEN SHE DROVE OFF DUE TO HER FEARING HE MIGHT ASSAULT HER. WE THEN WENT TO THE RESIDENCE OF THE SUBJECT AND UPON ARRIVAL HE ADVISED US OF THE SAME INCIDENT. HOWEVER THE SUBJECT ADVISED US THAT HE WAS GOING TO LEAN IN TO SPEAK WITH HER SO THE NEIGHBOR HOOD WOULD NOT HEAR THEM SPEAKING TO ONE ANOTHER WHEN SHE DROVE OFF. THE SUBJECT STATED THAT HE WAS JUST GOING TO SPEAK TO HER AND NOT ASSAULT HER. BOTH THE COMPLAINANT AND THE SUBJECT WERE A [REDACTED] BOTH WERE ALSO ADVISED TO STAY AWAY FROM EACH OTHER RESIDENCE AND TO NOTIFY THE POLICE DEPARTMENT IF EITHER SHOULD ARRIVE AT THE RESIDENCE UNWANTED.
