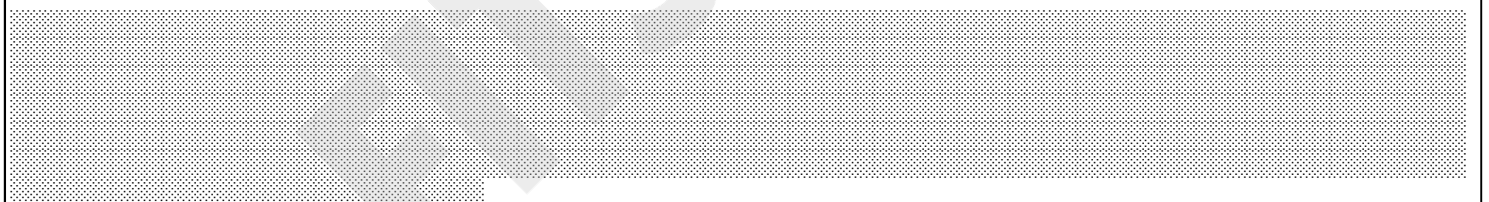

I was advised that there was an individual in the PD's lobby that wished to file a report for a missing person. Upon arrival, I made contact with the complainant / victim. He stated that his wife, the listed subject, had been released from [REDACTED] on June 11th, 2026, prior to 1400 hours. [REDACTED] had provided a cab for the subject, which stopped at her request at the I/L. That was the last time the subject was seen by the cab driver, who had attempted to make contact with her within the store after she had not returned outside. The victim stated that the subject had been known to frequent the area of Planet Fitness, and was able to make contact there. A Planet Fitness employee advised the victim that the subject's information had been used to sign in at that location at approximately 1838 hours on the 11th. After those incidents, no one has had further contact with the subject.
