NARRATIVE

ON 07/02/2026 AT APPROXIMATELY 0019HOURS, I OFC. NELSON WAS PATROLLING THE 1300 BLOCK OF E ASHLEY AVE, FOLLY BEACH, CHARLESTON COUNTY, SOUTH CAROLINA 29439 WHEN I OBSERVED A WHITE TOYOTA LAND CRUISER (SC TAG BEARING: 107487FM) FAILING TO MAINTAIN ITS LANE.

AS E ASHLEY AVE IS A NARROW ROAD, MINOR SWERVING IS COMMON, HOWEVER DUE TO THE AMOUNT OF TIMES THE VEHICLE WENT FROM THE CENTER LINE TO THE FOG LINE AND BACK, I INCREASED MY SPEED TO OBSERVE THE DRIVING BEHAVIOR OF THE VEHICLE TO DETERMINE WHETHER A TRAFFIC STOP FOR A GENERAL WELFARE CHECK OR POSSIBLE DUI WAS WARRANTED. THE WHITE TOYOTA LAND CRUISER THEN PULLED OVER TO THE SIDE OF THE ROAD WHICH I BELIEVED WAS A OPPORTUNITY TO INVESTIGATE THE REASON BEHIND THE DRIVING BEHAVIOR. I STOPPED BEHIND THE VEHICLE AND ADVISED DISPATCH OF A TRAFFIC STOP ALONG WITH MY FRONT FLOOD LIGHTS ACTIVE AND MY REAR EMERGENCY VEHICLE LIGHTS ACTIVE.

I MADE CONTACT WITH THE DRIVER, RONALD DEAN RALLIS JR. (IDENTIFIED BY HIS SCDL.) RALLIS JR. SHOWED SIGNS OF POSSIBLE IMPAIRMENT WITH GLASSY, AND WATERY EYES.

WHILE SPEAKING WITH RALLIS JR. I ASKED WHY HE WAS PARKED ON THE SIDE OF THE ROAD. (THE 1500 BLOCK OF E ASHLEY, WHERE PAYING TO PARK IS REQUIRED FROM 0800-2300 HOURS AND NO OVERNIGHT PARKING ALLOWED.) RALLIS JR. STATED THAT HE WAS NOT PARKED, BUT PULLED OVER SO THAT I COULD PASS HIM. I FOUND HIS STATEMENT INCONSISTENT BECAUSE WHEN RALLIS JR. VOLUNTARILY PULLED OVER I DID NOT HAVE MY EMERGENCY VEHICLE LIGHTS ACTIVE. AS OUR

CONVERSATION CONTINUED, RALLIS JR. BECAME VERY AGITATED. I ASKED RALLIS JR. FOR HIS LICENSE, REGISTRATION AND PROOF OF INSURANCE TO WHICH HE DECLINED TO PROVIDE BY SAYING "NO".

I ASKED FOR ADDITIONAL UNITS TO COME TO MY LOCATION. AS OTHER UNITS WITH MORE DUI EXPERIENCE, THAN MYSELF SPOKE WITH RALLIS JR. THEY INDEPENDENTLY SUSPECTED THAT RALLIS JR. WAS UNDER THE INFLUENCE OF ALCOHOL. I CONTINUED WITH MY INVESTIGATION AND READ RALLIS JR. HIS MIRANDA RIGHTS AT APPROXIMATELY 0039 HOURS WITH BWC ACTIVATED. I ASKED RALLIS JR. TO PERFORM STANDARDIZED FIELD SOBRIETY TEST TO WHICH HE REFUSED.

BASED ON MY OBSERVATIONS OF RALLIS' JR. DRIVING BEHAVIOR, AND THE TOTALITY OF THE CIRCUMSTANCES, RALLIS JR. WAS PLACED UNDER ARREST AT APPROXIMATELY 0040 HOURS.

RALLIS JR. WAS TRANSPORTED TO FOLLY BEACH POLICE DEPARTMENT HQ AND SEATED IN THE BREATH ALCOHOL TESTING ROOM. IMPLIED CONSENT WAS READ AT APPROXIMATELY 0055HRS. RALLIS JR. REFUSED TO GIVE A BREATH SAMPLE AT APPROXIMATELY 0100HOURS.

RALLIS JR. WAS TRANSPORTED TO CHARLESTON COUNTY DETENTION CENTER FOR IN-PROCESSING WITHOUT INCIDENT.
