Upon information and belief, the defendant Michilae Herring, the mother of Javeayah Harris (four years of age), caused the death of Javeayah who is under the age of eleven, while committing child abuse or neglect, and the death occurs under circumstances manifesting an extreme indifference to human life by not seeking medical attention for Javeayah after knowing that Javeayah suffered injury which was obtained from physical abuse. This information was obtained by the defendant's confession and co-defendant's confession. The defendant lives in the home at 39 Hillsboro St., Aiken, SC in the County of Aiken with the Javeayah. This happened between May 1 and June 15 or 2026 being in violation of SC Statute 16-3-85 of the code of laws as amended.
