**ORDER OF SUMMARY SUSPENSION**

**SUMMARY OF THE CASE**

The State Board of Education (State Board) considered this matter on December 10, 2025. In accordance with S.C. Code Ann. § 1-23-370(c) (2020), § 59-5-10 (2020), and State Board Rule of Governance BBABA, the South Carolina Department of Education (SCDE) requested that the Chair of the State Board summarily suspend the educator certificate of Sade Nelson, educator certificate 311509, as a result of her arrest for arrest for domestic violence of a high and aggravated nature (S.C. Code Ann. §16-25-65(A)) and unlawfully placing a child at risk of or causing harm to or willfully abandoning a child (S.C. Code Ann. §63-5-70).

The SCDE has reason to believe that, due to the serious nature of these allegations of misconduct, Ms. Nelson may pose a threat to the health, safety, and welfare of students, who may be under her instruction and that emergency action is required. After considering the evidence presented by the SCDE, the Chair of the State Board finds that Ms. Nelson’s educator certificate shall be summarily suspended until a due process hearing is held and/or this matter is otherwise resolved. The SCDE is directed to serve notice on Ms. Nelson of the summary suspension, as well as the possible suspension or revocation of her educator certificate.

**FINDINGS OF FACT**

Ms. Nelson holds a South Carolina educator certificate and has over twelve years of educator experience. At the time of the incident, Ms. Nelson was a school counselor for Charleston County School District (District). She has not resigned from the District but was placed on administrative leave.

On or about October 29, 2025, Ms. Nelson was arrested for domestic violence of a high and aggravated nature (S.C. Code Ann. §16-25-65(A)) and unlawfully placing a child at risk of or causing harm to or willfully abandoning a child (S.C. Code Ann. §63-5-70).

The SCDE has reason to believe that, due to the serious nature of this allegation of misconduct, Ms. Nelson may pose a threat to the health, safety, and welfare of students who may be under her instruction, and that emergency action is required. After considering the evidence presented by the SCDE, the Chair of the State Board finds that Ms. Nelson's educator certificate shall be summarily suspended until a due process hearing is held and/or this matter is otherwise resolved. The SCDE is directed to serve notice on Ms. Nelson of the summary suspension, as well as the possible suspension or revocation of her educator certificate.

#### **CONCLUSIONS OF LAW**

"The South Carolina Board of Education may, for just cause, either revoke or suspend the certificate of any person." S.C. Code Ann. § 59-25-150 (2020); S.C. Code Ann. § 59-25-160 (2025). Just cause includes unprofessional conduct, crime against the law of this State, and evident unfitness for position for which employed. S.C. Code Ann. § 59-25-160 (2025); 24 S.C. Code Regs. 43-58 (2021). In accordance with S.C. Code Ann. § 1-23-370(c) (2020), "If the agency finds that the public health, safety or welfare imperatively requires emergency action and incorporates a finding to that effect in its order, summary suspension of a license may be ordered pending proceedings for revocation or other action." Pursuant to S.C. Code Ann. § 59-5-10 (2020) and State Board Rule of Governance BBABA, the Chair of the State Board finds that as a result of the allegations of Ms. Nelson's unprofessional conduct, crime against the law of this State or the United States, and evident unfitness for the position for which employed, due to her arrest for domestic violence of a high and aggravated nature (S.C. Code Ann. §16-25-65(A)) and unlawfully placing a child at risk of or causing harm to or willfully abandoning a child (S.C. Code Ann. §63-5-70), there is reason to believe Ms. Nelson may pose a threat to the health, safety, and welfare of students and emergency action is required.

Accordingly, the educator certificate of Sade Nelson, certificate number 311509, is summarily suspended until a due process hearing is held and/or this matter is otherwise resolved. The SCDE is directed to serve notice on Ms. Nelson of the summary suspension, as well as the possible suspension or revocation of her educator certificate.
