1 FRANK MCMURROUGH 911 CALL

5 Dispatcher: Horry County 911. What's the address of
6 your emergency?

7 Mr. McMurrough: I am -- I don't even know. I just came
8 down from a -- one second. I am really sorry. Somebody
9 just shot somebody in the middle of the road. I am on
10 the corner of Camp Swamp Road. And somebody just
11 unloaded shots through his windshield and -- and shot
12 this guy.

13 Dispatcher: Okay.

14 Mr. McMurrough: I'm at the corner of Highway 9 and,
15 Highway 9 and Swamp Creek Road.

16 Dispatcher: Okay. What's your first and last name?

17 Mr. McMurrough: Frank McMurrough.

18 Dispatcher: Alright.

19 Mr. McMurrough: The -- the gentleman ---

20 Dispatcher: Alright, can you spell your last name for

1 me?

2 Mr. McMurrough: The gentleman that (inaudible), yep.

3 M-C-M-U-R-R-O-U-G-H.

4 Dispatcher: O-U-G-H. And the phone number you're
5 calling me from Mr. Frank?

6 Mr. McMurrough: Oh my god. 804-317-5534.

7 Dispatcher: Okay. And what's going on? I know you said
8 shots fired there.

9 Mr. McMurrough: Okay so a guy got out of his truck.
10 He's in a black truck. He got out of his truck with a
11 pistol drawn, the -- the slide was open. He told the
12 guy, "Do not follow me anymore." The guy in the white
13 truck had his gun drawn, pointed at him and the guy in
14 the black truck kind of like moved his pistol. And the
15 guy in the white truck just unloaded a complete
16 magazine at the guy. Shot through his back window and I
17 think he might have hit him.

18 Dispatcher: Okay. And what color of the vehicle, was
19 the vehicle that the individual was in that, actually
20 shot the weapon?

1 Mr. McMurrrough: It's -- it's -- it's -- it's a white
2 Dodge Ram with a trailer on it. There both sitting
3 there. I do not see the guy that shot (inaudible) ---

4 **Dispatcher: Dodge Ram with trailer.**

5 Mr. McMurrrough : --- the guy that did the shooting, did
6 not get out of his truck. I'm not going to -- Holy
7 shit. I mean I -- I was driving by and bullets were
8 going by (inaudible) I'm like ---

9 **Dispatcher: And, alright, you're -- you're okay. And**
10 **this was into the black truck? What kind of truck was**
11 **the black truck?**

12 (1:46)

13 Mr. McMurrrough: The black truck looks like a Dodge Ram
14 too. He shot at the guy and completely blew out his
15 back window. I don't know if there's kids in that car.
16 I don't know who's in that car, but I mean he just
17 unloaded into the truck.

18 **Dispatcher: (inaudible) Shots were unloaded into the**
19 **black Dodge. Alright, I am just getting that**
20 **information in there. And you said that you thought**

1 somebody was hit with the shots that went in there?

2 Mr. McMurrough: I mean it looked like he was hit. I
3 don't know, I don't know, I don't see the guy.

4 **Dispatcher: Okay. Are you still in the area or are you**

5 ---

6 Mr. McMurrough: I'm right -- I'm right behind them
7 now, yeah.

8 **Dispatcher: Okay.**

9 Mr. McMurrough: It's -- it's -- the one that shot was
10 a Dodge TRX white truck. The -- the car that was shot
11 into was a black Chevy Silverado.

12 **Dispatcher: Okay. So, it's actually a black Chevy**
13 **Silverado?**

14 Mr. McMurrough: Yeah. Camp Swamp Road, right at the
15 corner.

16 **Dispatcher: Okay.**

17 Mr. McMurrough: Roll your window down.

18 **Dispatcher: Alright we do have; we do have a call in**
19 **there. So, then we are going to have people responding**
20 **out there, okay? I just want you to keep yourself safe**

1 as well.

2 Mr. McMurrough: (inaudible) I know I saw it. I just
3 want to check on him. Okay. I know -- I know. Okay,
4 okay. Yeah. Okay. Alright. Okay. I'm still here.

5 **Dispatcher: Okay, I'm just listening to what's going**
6 **on, okay? Alright, where are you exactly in relation to**
7 **those vehicles?**

8 (3:43)

9 Mr. McMurrough: I'm behind them. I just spoke to the
10 driver in the white truck. I'm backed up off of Swamp
11 Road on Highway 9.

12 **Dispatcher: Okay. I just want you to keep yourself and**
13 **your passenger safe as well, okay? But we do have help**
14 **coming out there.**

15 Mr. McMurrough: I'm back, I'm backed up out of any
16 type of crossfire from it.

17 **Dispatcher: Okay. Okay. Alright and are the vehicles**
18 **pulled over and Camp Swamp Road?**

19 Mr. McMurrough: The -- the -- the -- they're on --
20 they're -- they're on Camp Drive. On Camp Swamp Road

1 when you pull in. There's -- there's a white truck, the
2 driver's out talking to people, trying to tell people
3 not to go up there. He's in the middle of the road. You
4 really can't even drive, no one's trying to pass,
5 because that dude up there ---

6 **Dispatcher: Okay.**

7 Mr. McMurrough: --- they don't know what's going. The
8 guy that got shot; I think.

9 **Dispatcher: Okay. But they're not on 9 anymore.**

10 **They're off on Camp Swamp Road?**

11 Mr. McMurrough: Right when you turn in on ---

12 **Dispatcher: Okay.**

13 Mr. McMurrough: --- (inaudible) Camp Road, yes.

14 **Dispatcher: Okay. Alright I just wanted to go ahead on**
15 **-- put that in there for the responding officers.**

16 Mr. McMurrough: Sorry. I'm -- I'm calm now. But I
17 literally was driving by, and shots were being fired
18 by. I apologize for cussing.

19 **Dispatcher: That -- that's alright, I understand.**

20 **Thank you for calling in and letting us know about it**

1 **though. But I was just updating that information in**
2 **there.**

3 **Mr. McMurrough: Thank you ma'am.**

4 **(5:24)**

5 **Dispatcher: Alright. Alright.**

6 **Mr. McMurrough: Yeah, the guy in the black truck**
7 **jumped out with a pistol. The guy in the white had his**
8 **pistol pointed at him obviously (inaudible) the guy in**
9 **the black jumped out with a pistol. That guy was -- the**
10 **pistol moved it; the guy just shot.**

11 **Dispatcher: Okay.**

12 **Mr. McMurrough: I don't know who -- I don't know who**
13 **shot first. But I -- I just know that the guy in the**
14 **white, you know once, oh boy. I think he's dead. I**
15 **can't even see him. I don't know if he's off in the**
16 **woods, if he ran, if he's in his truck. I wanted to**
17 **pull up to see if he's okay. I just don't want to get**
18 **shot at.**

19 **Dispatcher: Okay. That's no problem. I want you to**
20 **keep your -- I want to keep you and your passenger safe**

1 in there, okay?

2 Mr. McMurrough: I think they both returned fire at
3 each other. Nobody knows where the gentleman in the
4 black truck is. No one. Like we can't see him.

5 **Dispatcher: Okay.**

6 Mr. McMurrough: He is not -- just when the officers --
7 I just want the officers to be safe when they get here.

8 **Dispatcher: And you said no one knows what, where the
9 driver from the black truck is?**

10 Mr. McMurrough: No. Yeah, he -- he.

11 **Dispatcher: And Mr. Frank ---**

12 Mr. McMurrough: Okay. Ma'am. So just -- just so you
13 know, there's somebody else that saw it. The guy in the
14 black truck was trying to run the white truck off the
15 road. Like literally drove the white truck off the
16 road. He was like way down at Longs when it started.
17 The guy in the black truck was chasing the white truck
18 down, trying to drive him off the road. Then, that's --
19 I guess what he's -- when he got out with his pistol
20 and that's when I saw it. But there's other people here

1 that said this guys been chasing this guy in the white
2 truck for a couple miles now, trying to drive
3 (inaudible) ---

4 **Dispatcher: Okay.**

5 Mr. McMurrough: --- trying to throw him off the road,
6 so.

7 **Dispatcher: Alright, I am just updating all this**
8 **information in there, okay?**

9 Mr. McMurrough: Yeah, I just want to get as much for
10 y'all as I can. So, I ---

11 **Dispatcher: Okay.**

12 Mr. McMurrough: --- I don't know who's wrong or who's
13 right.

14 **Dispatcher: Could you get me the license plate**
15 **numbers? On the vehicles, on the trucks? If your close**
16 **enough and if it's safe enough?**

17 (7:25)

18 Mr. McMurrough: Yeah. The white truck looks like 5572.
19 He's got a -- he's got a black -- I cannot see the
20 Chevy.

1 **Dispatcher: Okay.**

2 Mr. McMurrough: I cannot see the Chevy.

3 **Dispatcher: Alright. And all you can get off the white**
4 **truck is the 5572?**

5 Mr. McMurrough: Yeah, I think it's like a 1 or a V but
6 it looks like a 5572. That gentleman is on -- also on
7 the phone with 911. He called himself, I think.

8 **Dispatcher: Okay. Okay. Alright and then could you**
9 **tell for that white truck if it is a -- a South**
10 **Carolina license plate?**

11 Mr. McMurrough: Is that a South Carolina license
12 plate? Do you know, I'm not from down here. The black
13 truck does have a South Carolina license plate. This
14 one I'm not tell; it's got one of those black things
15 over it so it's hard to see during the day.

16 **Dispatcher: Okay.**

17 Mr. McMurrough: I think so. Yeah. No, that black's
18 been chasing this guy for miles, I guess. The black
19 trucks been chasing this guy miles. They saw the whole
20 thing. And then the black truck stopped, the guy jumped

1 out with a pistol. Yeah. Yeah, I'm on the phone with
2 911. I told her.

3 **Person 1:** He got out, and then had a gun. He racked
4 it (inaudible) and I mean we just -- you can't do that.

5 **Mr. McMurrough:** He's dead? Guys dead. He's dead.

6 **Dispatcher:** Okay. Which truck? The driver of which
7 truck?

8 (9:22)

9 **Mr. McMurrough:** Driver of the black truck is dead. The
10 guy in the -- the guy in the white truck walked up to
11 check on him and he said he's dead. Oh my god.

12 **Dispatcher:** Okay. I am putting that in here, okay? We
13 are having officers come there. There is an officer
14 coming down Highway 9 right now.

15 **Mr. McMurrough:** Right now, there is some witnesses.
16 The driver of the white truck does not have a firearm
17 on him. Everyone's calmed down. But he just said he's -
18 -- he walked up and saw him and the guys dead.

19 **Dispatcher:** Okay. Alright, we do have officers coming
20 there, okay?

1 Mr. McMurrough: Yes, ma'am thank you.

2 **Dispatcher:** Do not disturb anything in that truck. And
3 if you can, go ahead and tell people around there not
4 to disturb anything in there either, okay?

5 Mr. McMurrough: Okay. Alright.

6 **Dispatcher:** And you said you still don't know whether
7 the driver of the white truck is?

8 Mr. McMurrough: Hey, hey sir, sir, sir, sir, do you
9 know where the driver is?

10 Person 2: He's in his seat right now.

11 Mr. McMurrough: He's -- he's in his truck, in his seat
12 right now. They don't want -- they said he's deceased.
13 They don't want us to go near the truck or touch
14 anything until they get here.

15 Person 2: Okay, the other guy told, okay.

16 Mr. McMurrough: Just so you know.

17 **Dispatcher:** Yeah, we do have an officer coming down
18 there, okay? He's coming down ---

19 Mr. McMurrough: Okay.

20 **Dispatcher:** --- Highway 9 now. But I'm going to stay

1 on the phone with you until he arrives, okay?

2 Mr. McMurrough: Yeah. That white pickup truck is a
3 Veteran South Carolina tag with the 5572.

4 **Dispatcher: Okay.**

5 (10:48)

6 Mr. McMurrough: Oh my god.

7 **Dispatcher: And you guys are standing well clear of
8 the traffic, aren't you?**

9 Mr. McMurrough: Yes ma'am. Everyone's kind of out of
10 the way. You're not going to be able to turn. I can --
11 I can hear the sirens now.

12 **Dispatcher: Okay.**

13 Mr. McMurrough: Officer's arrived.

14 **Dispatcher: Okay. Okay and then can I get a
15 description of what vehicle you're in incase the
16 officer wants to speak with you there?**

17 Mr. McMurrough: Yes. I'm actually -- I'm actually -- I
18 apologize. I'm facing the wrong way on ---

19 **Dispatcher: Okay.**

20 Mr. McMurrough: --- on 9. But way off, well to the

1 shoulder. I'm in a -- a grey Chevy Colorado. My license
2 plate, it's a Virginia tag. Do you need that?

3 **Dispatcher:** Just so the officer can identify you
4 there.

5 Mr. McMurrough: Okay. TRM4682. I'm on the side of the
6 road with my wife.

7 **Dispatcher:** Okay, you said 4683?

8 Mr. McMurrough: 4682.

9 **Dispatcher:** 82 okay. If the officer wants to speak
10 with him. Alright, is the officer there on scene now?

11 Mr. McMurrough: Yes, he's talking to the gentleman in
12 the white truck that shot with the other guy.

13 **Dispatcher:** Okay. Just keep yourself safe there. I do
14 have all of that information in there. And then if
15 anything changes or gets any worse, call us back
16 immediately, okay?

17 Mr. McMurrough: Okay.

18 **Dispatcher:** Alright, thank you.

19 Mr. McMurrough: Thank you.

20 **Dispatcher:** Alright, you're welcome. Bye.
