**AMENDED CONSENT ORDER FOR THE
 PRODUCTION OF MEDICAL RECORDS
 AND PHARMACY RECORDS
 OF CHARLES WELDON BOYD**

This matter comes before the Court upon the Motion to Quash Subpoena filed by the Defendant, Charles Weldon Boyd, regarding medical records and pharmacy records of Charles Weldon Boyd sought to be obtained from Strand Psychiatric Associates, Dr. Hanna Kloch, CVS Pharmacy, Walgreens Pharmacy and Cherry Grove Drug. The Defendant has now withdrawn its objection to the subpoenas, subject to the condition that the documents produced are marked as confidential pursuant to the terms of this Order.

IT IS HEREBY ORDERED:

1. Production of Documents:

Strand Psychiatric Associates, Dr. Hanna Kloch, CVS Pharmacy, Walgreens Pharmacy and Cherry Grove Drug are ordered to produce the following records to the Plaintiff:

Any and all medical records, reports, documents, inter-department notes or records, including but not limited to, any and all psychiatric records, EMS report and/or records, statements for services, test results, x-ray results, radiology records/films/images, progress notes, consultation notes, office notes, nurses' notes, health care questionnaires, correspondence, bills for services rendered, evaluations, interviews, charts, diagrams, treatment plans, medical flow charts, telephone call reports, medical logs, disability determination information, and any other' written or printed information in your medical file concerning treatment of Charles Weldon Boyd, DOB: 12/31/1990.

2. Confidential Designation:

All documents received by the Plaintiff in this litigation and produced pursuant to this

Order shall be marked by the Plaintiff as "Confidential" and shall be subject to the terms and protections outlined in the Confidentiality Order previously entered in this matter.

3. Use of Confidential Information:

The documents designated as "Confidential" shall be used solely for purposes of this litigation and shall not be disclosed to or discussed with any person except:

- The Parties to this litigation;
- Attorneys of record and their employees assigned to assist in the conduct of this action;
- Consultants or designated experts;
- Witnesses, but only to the extent the Confidential Information is reasonably related to their testimony;
- Court reporters employed in connection with this action; and
- The Court.

4. Prohibition on Public Disclosure:

The Confidential Information shall not be publicly disclosed or disseminated in any manner, nor shall it be used for any business or competitive purpose, publicity, or any purpose unrelated to this litigation.

5. Reservation of Rights:

Nothing in this Order shall be construed as a waiver of any privilege or protection applicable to the documents produced, nor shall it preclude any Party from seeking further relief from the Court regarding the use or disclosure of Confidential Information.

6. Modification of Order:

This Order may be modified only by further order of the Court or by written agreement of the Parties.
