 On 6/8/2026 I responded to 300 Randall St in reference to an assault incident. 300 Randall St is within the city limits of Greer, Greenville County, South Carolina.

Officers were already on scene at the time of the incident for a related political event. Officer had already made contact with the victim [REDACTED] who had been legally protesting the political event from a public location.

Shortly after the event, a Blake Kirsch who had also been at the event but who had not had any prior contact with [REDACTED] ran up to [REDACTED] who was holding a megaphone and ripped the megaphone out of [REDACTED] hands. Kirsch then ran up to myself and other officers and handed us the megaphone. I advised Kirsch to give it back and that he could face charges at which time [REDACTED] approached and demanded charges to be pressed against Kirsch because he
