On Tuesday September 16th 2026 at approximately 1830 hours, I Deputy King responded to a reported assault at Georgetown County Detention Center, 2394 Browns Ferry Rd in the Town North Section of Georgetown County SC.

Upon meeting with staff in the booking area, they were able to bring V1/O1 (JH) to the booking area. V1/O1 (JH) advised that staff was trying to put him in a new cell. He stated that he had been having issues with V2/O2 (JB) since he arrived and that he had been threatened by V2/O2 (JB). He stated that when he was in the same cell that V2/O2 (JB) hit him in the face twice, making his nose bleed, and also in the left side in the ribs. V1/O1 (JH) states he was hit a total of 3 times in the face believing that he may have a broken jaw

and possibly a broken rib. He further stated that he did nothing to deserve to be in jail and that he was attacked and did not touch V2/O2 (JB), wanted to speak with his lawyer and asked also to speak with his wife. Photographs were taken, however there were not any visible signs of injury, swelling or redness at the time. V1/O1 (JH) was taken back to his cell by jail staff.

V2/O2 (JB) was then brought to the booking area. V2/O2 (JB) stated he was in his cell, and that he had already made complaints about V1/O1 (JH) because since his arrival he had been threatening, him and other people in the jail and trying to start fights with other people. V2/O2 (JB) stated that today when V1/O1 (JH) entered the cell, he told V1/O1 (JH) that he would have to sleep on the floor or top bunk. V2/O2 (JB) stated that V1/O1 (JH) became irate and then threw water on him, pushed him, and struck him in the face but declined any pain. Photographs were taken, however here were not any visible signs of injury swelling or redness at the time.

Booking staff attempted to get a copy of any grievances filed but stated I would need to follow up with Captain Washington upon her return tomorrow morning as it was already after hours.

Due to being unable to determine the primary aggressor, both parties were charged with County Simple Assault on a UTT. Citations provided to booking staff as well as victims forms.
