On 09/10/2026 I responded to a domestic dispute call for service at 16 Marina Rd in Richland County.

Upon arriving I made contact with the subject Robert Marzol. Robert stated that his granddaughter began screaming while at dinner at Liberty on the Lake. Robert stated that he and dad told stop and she did not listen and continued screaming. Robert stated that he then grabbed by the hand and began escorting her outside. Robert stated along the way she was pulling against him so he grabbed her arm to continue escorting Robert stated after arriving at the car he sat her on the rear bumper to verbally discipline her.

Witnesses and stated that they observed Robert pulling by her arm and upon arriving to Roberts vehicle, Robert slammed into the vehicle and began violently shaking her by both her arms and verbally abusing her. stated they then observed Robert open hand smack on the back of her neck.

I then spoke with who stated Robert brought her outside by her arm and that her arm "hurts a little bit" and stated multiple times that "that man did that" referring to Robert causing the injuries. I observed minor contusions and red marks on arms and on the back of her neck that corroborated the witnesses story. I then radioed for an ambulance to be dispatched to check injuries. Upon arrival EMS evaluated and reported to me that they observed minor contusions and marks on arms and the back of her neck that corroborated the witnesses story. I then took photos of injuries.

Robert was then read his Miranda rights and placed under arrest for Assault and Battery 3rd and Unlawful Conduct Towards a Child. I conducted a search incident to arrest and secured him the back of my patrol vehicle.
